The EVM Challenge announced by the Election

Commission of India.

Sir.

Transparency, accountability and fairness of the election process are intrinsic to our democracy. A free, fair and transparent election is the first fundamental of our polity. In this context, we welcome this initiative to remove every iota of doubt raised by certain sections of the polity with regard to tampering of EVM machines. We are of the opinion that this challenge must be fair, transparent and unambiguous in terms of scope, scale and rules.

Unfortunately, the extensive terms and conditions that this challenge imposes prevent challengers to conduct a thorough test of the EVMs. We urge you to reconsider relaxing the three rules of this challenge, as their inclusion undermines the very credibility of this initiative.

First, the challengers will be only given access to the Control Units and Ballot Units. Second, the terms of access allows them to only press buttons. And third, the challenge is based on the premise that tampering should be demonstrated only when the EVMs are in the strong rooms or at the counting booths.

The EVM machine is composed of more components apart from the Control Unit and Ballot Unit. If challengers don't have access to all the components – such as the motherboard - that constitute an EVM, how will they demonstrate their concerns? The EC must factor the possibility that those who would try and tamper with EVMs in real life scenario can do so without pressing buttons on the CU or BU or do it before/after the EVMs are in the control room.
